PAYMENT – In order to initiate a booking, a non-refundable deposit is required per person travelling in the group. Payment of deposit reflects acceptance of our terms and conditions, all deposit payments and final payments are non-refundable.

Payments Required

BALANCE DUE	120 days prior to travel

Failure to comply with Celtic Golf's payment schedule may result in cancellation of the booking and loss of funds paid.

PAYMENT METHODS – Celtic Golf accept payment in USD/\$ only, available payment methods include:

PRICING – all Celtic Golf programs are based on the costs and exchange rates that have been contracted with our vendors. Therefore, prices quoted are guaranteed and no price adjustment will be made due to any fluctuation in currency rates.

CHANGES – once a program has been booked and confirmed an administrative fee of \$50.00 will be charged for the subsequent changes made to a tour. Changes made resulting in lost deposits will be charged to the client.

GENERAL
